This includes decisions in regard to any procedure that affects my bodily functions such as artificial respiration, hydration, artificial respiration, cardiopulmonary resuscitation, and any other form of medical support, even if the refusal or withdrawal of treatment could or would result in my death.
- (b) _____-To have access to all my medical records and information to the same extent as I am entitled to, including the right to disclose health information to others.
- (c) _____-To hire and fire any medical, social service, and other support personnel who are responsible for my care.



- (d) _____-To refuse or to agree to using any medication or procedure intended to relieve pain or discomfort, even though that use may lead to physical damage or dependence or accelerate (unintentionally) my death.
- (e) _____-To contract for any health care-related service or facility for me, or apply for private or public health care benefits, with the understanding that my agent is not personally financially responsible for those contracts.
- (f) _____-To authorize my admission to or discharge from any hospital, nursing home, residential care, assisted-living or similar facility or service.
- (g) _____-To decide about organ and tissue donations, autopsy, and the disposition of my remains as the law permits.
- (h) _____-To authorize my participation in medical research related to my medical condition.
- (i) _____-To take any other action necessary to do what I authorize here, including signing waivers or other documents, pursuing any dispute resolution process, or taking legal action in my name.
