**BUYER WARRANTIES.** Buyer gives no warranties except for the following (Buyer will sign on the space beside all applicable):

**GOVERNING LAW.** The Interpretation of this Bill of Sale shall be in accordance with the laws of the State of South Carolina, without regard to the conflict of laws principles of each State, and all disputes or claims in relation to this Agreement shall be commenced in the exclusive jurisdiction of the Courts of the same State.
