\_\_\_\_\_ Seller will execute further documents as may be reasonably necessary to effect the complete transfer of the Firearm to the Buyer or its assigns.

**BUYER WARRANTIES.** Buyer gives no warranties except for the following (Buyer will sign on the space beside all applicable):

**GOVERNING LAW.** The Interpretation of this Bill of Sale shall be in accordance with the laws of the State of Vermont, without regard to the conflict of laws principles of each State, and all disputes or claims in relation to this Agreement shall be commenced in the exclusive jurisdiction of the Courts of the same State.
